has been designated and selected by a majority of the including but not limited to: Assistant Engineer, Staff Engineer, Clerk's, Administrative Assistants, Building Official, Account Clerks/Fiscal Clerks, Assessor's Aide, Tax Assessor, Chief Accountant, System Operator, Deputy Town Clerk, Highway Superintendent, Secretary-Detective Division, Superintendent of Sewer Plant, Assistant Superintendent of Sewer Plant, Lab Technician, excluding Department Directors and the Executive Secretary

as their sole representative for the purpose of collective bargaining and that pursuant to the provisions of 28-7-16, (1) of the Act, the National Education Association/Rhode Island

is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
