**ORDER:** 1) The Employer is hereby ordered to Cease and Desist from permitting any non-Union employees from performing work that was previously performed by the Director Alumni Relations and the Assistant Director of Development and Annual Fund, as those positions are described by Union Exhibits #1 and #3 and as outlined on Union Exhibit #5. 2) The Employer is hereby ordered to pay to the Union, a sum of money, which is equal to the amount of dues at the normal rate that would have been paid by the Union Members, since the filing of this petition, for each and every non-union position that is performing duties that previously appeared on Union Exhibits #1 and #3. In addition, to the extent that any of the duties that were previously performed by the former Assistant Director of Alumni Relations position are still being performed by any employee not in the bargaining unit, the Union is entitled to a sum of money, which is equal to the amount of dues at the normal rate that would have been paid by a Union Members for that position, if it is an additional separate position than as ordered in the previous sentence. 3) The Employer is hereby ordered to post a copy of this Decision and Order for period of sixty (60) days on all common area bulletin boards for which notices for employees are posted.
