4. DECISION AND ORDER MATTERS: (Review and Determination/Signing):

(a) ULP- 6349 Rhode Island Department of Elementary and Secondary Education & RIDE Legal Counsel/Hearing Officer Professional Union

This case was heard formally on May 18, 2023 by Walter J. Lanni, Aronda R. Kirby, Kenneth B. Chiavarini and Harry F. Winthrop, as well as all Board Members present reviewed the transcript(s) and briefs, as well as the evidence submitted herein.

After review of the Drafted Decision and Final Order of Failure to Conclude on Substantive Grounds, a Motion was made by Harry F. Winthrop and seconded by Scott G. Duhamel to sign the Decision and Final Order of Failure to Conclude on Substantive Grounds, as written, and to refer the case back to the Programming Services Officer of the Board for final proofing; with the direction to issue the same as soon as possible. After discussion, there was a question as to which Board Members were Dissenters as the original Motion was a Motion to Deny and Dismiss the Complaint in this matter and there was a 3 to 3 tied vote. Attorney Kasle asked that the matter be temporary tabled so that he could verify if any changes needed to be made to the Decision.

A Motion was made by Aronda R. Kirby and seconded by Harry F. Winthrop to table this matter to allow Attorney Kasle to review and correct the wording concerning the original Motion which resulted in a 3 to 3 tied vote. All Board Members present voted in favor of the Motion. Motion passed.

A Motion was made by Aronda R. Kirby to go into Closed Session for the purpose of review/voting on the Closed Minutes and update on pending litigation, pursuant to R.I. Gen. Laws 42-46-5(a)(2)(4) of the Open Meetings Law. Harry F. Winthrop seconded the Motion, and it was unanimously

After discussion, Attorney Kasle stated that he needed to correct a typo in the draft Decision, as he had incorrectly identified the original Motion as a Motion to Uphold and it was originally a Motion to Deny and Dismiss, but otherwise there was no need to change the substance of the Decision. All Board Members present voted in favor of the Motion. Motion passed.

A Motion was made by Aronda R. Kirby and seconded by Stan Israel to sign the corrected Decision and Final Order of Failure to Conclude on Substantive Grounds, and to refer the case back to the Programming Services Officer of the Board for final proofing; with the direction to issue the same as soon as possible. There was no further discussion. All Board Members present voted in favor of the Motion. Motion passed.

ORDER: The Unfair Labor Practice Charge and Complaint in this matter are hereby dismissed.
