(a) **P.C. 2022-05508 Rhode Island Department of Elementary and Secondary Education v. Rhode Island State Labor Relations Board and RIDE Professional Employees Union, Local 2012, AFT (ULP- 6284) (Dismissal Stipulation)**

Attorney Kastle stated that this is an unfair labor practice matter that went back to 2022. The Board issued a Decision & Order in favor of the Union, and that Decision was appealed by RIDE to the Superior Court. After being prompted by the Superior Court for a status update on the matter, RIDE filed a Dismissal Stipulation, and the matter has been dismissed with prejudice and taken off the docket.
