Notice of Election

To Determine the Representatives for Collective Bargaining Purposes for the **THE MET SCHOOL**

Date and Purpose of Election

Pursuant to an Agreement for Consent Election signed by all parties on June 4, 2025, an election by SECRET BALLOT will be conducted by the State Labor Relations Board and/or its agents for the purpose of determining whether: All teaching positions that require a teaching certification; excluding all positions that do not require a teaching certification, supervisors, guards, and support staff desire to be represented by National Education Association Rhode Island (NEARI) or by no labor organization for the purposes of collective bargaining.

Eligibility and Lists of Voters

Those eligible to vote shall be All teaching positions that require a teaching certification; excluding all positions that do not require a teaching certification, supervisors, guards, and support staff, employed by The Met School, on the payroll during the week ending Friday, May 30, 2025. Eligible employees are requested to bring a picture identification card in order to vote; and shall be asked to display it for identification purposes only.

This notice and a list of the employees who are eligible to vote in this election will be posted in appropriate places on the employer's premises easily accessible to all concerned.

A duplicate voting list of eligible employees will be used at the election to verify the employees as they present themselves to vote. Should the name of any eligible employee be omitted from the voting list through error, upon proof of such error, that employee's name will be added to the voting list at or before the time of balloting; thus, allowing the employee the opportunity to vote. Only those employees named on the voting list will be allowed to vote. Likewise, in the event that an employee's name appears on the voting list through error, upon proof of such error, that employee's name will be eliminated from the list and that employee will not be allowed to vote. Duplicates of the list of eligible employees will be used at the election to check the employees as they present themselves to vote. Attention!

Section 28-7-40 of the Rhode Island General Laws, 1956, as amended, entitled Rhode Island State Labor Relations Act reads as follows:

Any person who shall willfully resist, prevent, impede, or interfere with any member of the Board or any of its agents or agencies in the performance of duties pursuant to this chapter, or who shall in any manner interfere with the free exercise by employees of their right to select representatives in an election directed by the Board pursuant to sections 28-7-14 to 28-7-19, shall be punished by a fine of not more than five thousand dollars (\$5,000) or by imprisonment for not more than one year, or both.

Authorized Observers

The Union and the Employer may each designate, subject to approval and appointment by the Board, one (1) observer who will have the following duties and privileges:

- (a) To act as monitors of the election process.
- (b) To assist the Agent of the Board in the conduct of the election.

Observers shall not engage in electioneering at any place on the day of the election.

Counting of Ballots

As soon as possible after the close of the voting, the ballots will be counted and tabulated by the Agent of the Board in charge of the election, assisted by other Agents of the Board and authorized Observers. The count will be made at a place selected by the Agent(s) of the Board.

Interference, Coercion, and Electioneering

Voters shall be allowed to vote without interference or coercion. Electioneering will not be permitted at or near the voting places. The Board expects voluntary compliance with this regulation; otherwise it will be strictly enforced.
